Are You REAL ID Ready?

Starting May 7, 2025, you must have a REAL ID to access certain federal facilities, including the credit union office located in the USEPA facility.

About REAL ID's...

The REAL ID Act was passed by Congress in 2005 and will be enforced starting May 7, 2025. The act established minimum security standards for state-issued driver's licenses and identification cards and prohibits certain federal agencies from accepting identification cards that do not meet these standards.

How do you know if you have a REAL ID?

Look for a star symbol in the upper right corner of your driver's license or state identification card. If it has a star, it is considered a Real ID compliant card. A U.S. Passport, U.S. Passport Card, and Military ID is also considered a REAL ID.

How do you get a REAL ID driver's license or identification card?

You can get a REAL ID at your local Bureau of Motor Vehicles (BMV). A compliant driver's license or ID Card requires documents to prove your full legal name, date of birth, Social Security number, proof of residency, and proof of legal presence. Visit your state driver's license website for details regarding document requirements.
